

Privacy Policy Moslight LLC

Company Moslight LLC. («Moslight LLC») is very serious about the confidentiality of personal information. We adhere to the principles of transparency in matters of confidentiality and try to provide you with control over their information regarding the use of Annex Moslight LLC (as defined in our [Terms and Conditions](#)).

This Privacy Policy outlines the approach Moslight LLC to the treatment of personally identifiable information ("Personal Information"), and other data collected Moslight LLC during your use of the Application. Services are not available to persons under 13 years of age.

What personally identifiable information is collected by Moslight LLC?

The personal information you provide to us: We receive and store information you input in the Appendix. You are aware that we may collect such personal information, such as your name, email address, date of birth, name of the user on Twitter, VK, Instagram and / or Facebook, location, information about your use of the Application. When you use an application, we automatically get your location. To determine the location, we use a variety of technologies such as geolocation service appropriate to the operating system, as well as sensor data to your device that may, for example, include information about nearby access points, Wi-Fi and mobile towers. Personal information you provide to us, in particular, allows you to set up an account and profile that can be used to interact with other users through the application helps improve application content, choose the information displayed by you and your friends, as well as send you special offers and new features . Your account application will be linked to your e-mail and will be used in the Appendix. For example, the location data obtained by us during your work in one of our applications can be used to customize the content displayed to you and your friends in another our application. We may also use your Personal Information to improve and develop new tools for our community. Information collected automatically: in the use of the applications you Moslight LLC automatically receives and records information in our journals from the mobile platform, including information such as your location, operating system, mobile operator ID, devices and applications. Except as otherwise required by law, such data are treated as impersonal information. Moslight LLC uses such information only in aggregate form.

How to use my personal information?

Positioning.
